# Opportunities in health care

## Purpose

The one-year Asante Three Rivers PGY-1 pharmacy residency program offers opportunities for postgraduate professional growth. In addition to the required training segments, the program allows numerous elective opportunities to complement your career goals. The program begins in late June.

The program builds on Doctor of Pharmacy, or PharmD, education and outcomes to contribute to the development of clinical pharmacists responsible for medication-related care of patients with a wide range of conditions. Those who complete the program are eligible for both board certification and postgraduate year-two, or PGY-2, pharmacy residency training.

## Timeline

**The application deadline is Jan. 2.**

Interviews are conducted in late January through early March, and the program begins in late June.

## Resident responsibilities

The resident is involved in all aspects of patient care throughout the health system. Resident responsibilities include:

- Providing direct patient care to diverse populations
- Assessing, monitoring and delivering pharmacotherapy
- Developing, implementing and evaluating a research protocol
- Participating in Asante Pharmacy & Therapeutics Committee activities
- Providing continuing education to pharmacy professionals
- Participating in community service activities
- Fulfilling clinical and staff pharmacist responsibilities
- Attending national, state and regional pharmacy meetings
- Presenting a poster at a national or state meeting
- Presenting major research at a regional conference
- Serving as authors for the Asante Pharmacy & Therapeutics Bulletin

Residents participate in a broad range of required experiential training segments. In addition to the required training, the program allows numerous elective opportunities to complement each resident's career goals. Training opportunities include:

Residency applicants must:

1. Possess or be receiving a Doctor of Pharmacy degree
2. Be licensed or eligible for licensure in the state of Oregon
3. Participate in the Match
4. Submit a completed PhORCAS application that includes:
  - Individual Assessment for Residency Training form (available at [asante.org/pharmacy-residency](https://asante.org/pharmacy-residency))
  - Three references
  - Pharmacy college transcripts
  - Letter of intent
5. Complete a formal interview
