

OSHP EAC Meeting Notes

April 8, 2020

Good morning everyone,

We had an abbreviated meeting yesterday evening with special guests (Andrew Gibler and Stacey Barrett) to discuss options for Fall Seminar 2020 in light of the rescheduling of Annual Seminar to September. As a group, and with the input of Andrew (currently president) and Stacey (OHSP association manager) we decided to proceed with a shortened Fall Seminar for 2020, but with the goal to retain a variety of interesting and useful programming for all of our constituents, including pharmacists, technicians, students and industry partners. We are planning to move ahead with a tentative schedule along these lines:

Stacey has a recommendation for a Keynote speaker who is local and has presented for a number of other organizations locally and she will pass that information on to use in the next few days. We will want to continue to target speakers, recognizing that this year we will not have a designated “Ambulatory Care” or “Acute Care” track and will want to probably include those key CE topics (Law, Patient Safety) that are always in high demand, without duplicating the presentations from Annual Seminar. There is also the new Cultural Competency requirement, but that does not go into effect for pharmacists until 2021, but might be starting for technicians with the next renewal cycle (Paige mentioned this previously, but I can’t recall exactly what she said the timeline would be for technicians). We could consider this in our planning. The student session (Student 1) I’ve added in an attempt to draw underclassmen away from the Residency Showcase for the first hour, to give our P3/P4 students from both pharmacy programs a chance to meet with residents in a less crowded environment. Students seemed to highly regard the “Networking for Success” session from last year, so potentially something along those lines, or related to getting a jump-start on building a competitive CV,

etc. would be attractive. There is always the possibility that the COVID-19 crisis will continue to put these events in jeopardy, so we will communicate to all speakers that there is a chance the event will be virtual, but that our goal is to have a live, in-person Fall Seminar in 2020!

Additionally, Kylee was not able to attend the meeting because earlier this week she and Arrash welcomed their new baby, Adrian Vahidi! Kylee reports that they are home and doing well, so congratulations to you guys! Kylee will be stepping out of the co-chair position and Megan Herink has expressed an interest in assuming this leadership role with me for next year and has the support of the Board of Directors. If any of you are interested in co-chairing EAC in the future, please let me know as we need to have a succession plan in place whenever possible. Thank you to Kylee for her long tenure as co-chair of EAC (at least 4 years now, I think?) and her continued involvement as a member as time allows.

Lastly, for those of you who have volunteered to help with student scholarships, I apologize that information has not been distributed already, but I plan to send that out TODAY, and we will target Monday, April 27th as our date to potentially conference call to review the rankings and confirm our winners. Thank you for your patience!

That's it – we have some work to do in the next couple of months, so please be thinking of who we should invite to speak, and what topics we should target to appeal to a broad group or our colleagues for this abbreviated Fall Seminar. We'll meet, as scheduled, the second Wednesday in May.
