    - 1. Mike provided updates
      - a. Coalition meeting on next Tues email Mike if interested in attending
      - b. Legislative session to start Feb 3, topics of interest are:
        - i. Gross receipt tax pursuing exemption for pharmacies as "agents"
        - Pharmacy dispensing naloxone co-prescribing preferred over co-dispensing. Issue with low volume is do to cost and payors not funding
        - iii. Pep and prep Protocol for pharmacist prescribing to be approved by board
        - iv. Proposal for drug import from Canada OSHP opposes
        - v. PBMs ongoing work
        - vi. Primary Care Workgroup being formed at state level will be ask for designated clinical pharmacist as member of taskforce, need to be appointed by Governor. Goal is to assess how to provide primary care to Oregonians. Important to ensure pharmacy has strong involvement and voice on this.
        - vii. Opioid taskforce currently has an OSPA member on it
